<b>Faculty Development Schemes</b>											
1]	<p><b><u>President-SES Research Motivational Scheme (PSRMS):</u></b></p> <p>Under, <b>the President-SES Research Motivational Scheme</b>, young faculty of colleges will be given a grant of ₹ 25,000/- to encourage them to carry out their proposed research. This grant will be offered to maximum two faculty/ College.</p> <ul style="list-style-type: none"> <li>▪ This award will be offered to faculty who is having experience above 2 Yrs and less than <b>5 Yrs</b> in SES/RCPET.</li> <li>▪ The grant will be provided just once throughout the faculty's tenure. The faculty shall submit the research proposal in the format specified.</li> <li>▪ The <b>Research Advisory Committee (RAC)</b> of institute will accept research proposals from faculty, and the chosen proposals will be forwarded to the SES, Shirpur central committee for final scrutiny. Based on the research project work, faculty will have to publish one research paper of minimum <b>1.0 IF</b>. The publication of the research paper will be considered as outcome of the scheme.</li> </ul>										
2]	<p><b><u>Best Teacher Award &amp; Best Supporting Staff Award (Registrar, Accountant, Librarian, Laboratory staff, Clerk and Peon)</u></b></p> <p>Every year on 5<sup>th</sup> September, SES will announce the Best Teacher Award and the Best Supportive Staff Award. The award consists of a memento, a citation, and a cash prize of ₹ 5100 (Best Teacher Award) and ₹ 2100 (for Best Supportive Award).</p> <ul style="list-style-type: none"> <li>▪ The faculty &amp; Supportive staff of all colleges are eligible for respective award.</li> <li>▪ Each college can forward maximum <b>two applications from each category</b> (for Student strength above 500 total 02 proposal from each category and strength less 500 total 01 proposal from each category)</li> <li>▪ for Best Teacher Award <b>-02 proposal</b> and for (Best Supportive Staff Award)</li> <li>▪ i.e., Clerk / Lab Assistant <b>-01 proposal</b> and &amp; Peon <b>- 01 Proposal</b></li> <li>▪ The applications should be submitted by faculty/ Supporting staff in given format through Principal/ Director.</li> <li>▪ The eligibility for application of this Awards ____.</li> <li>▪ For faculty, <b>minimum 10 Years</b> of Service in Shirpur Education Society /R. C. 3]	<p><b><u>Research Excellence Award – Funding</u></b></p> <p>Award comprised of prize of <b>Rs. 1100</b>, Certificate and Memento. Every year, this Award will be given to two faculty members of each college.</p> <p>Faculty members shall meet the following requirements</p> <ul style="list-style-type: none"> <li>▪ Recipient of <b>5 Lakhs or above Research/ Conference/ Seminar/ FDP grant</b> from various funding agencies in a calendar year.</li> <li>▪ Recipient of <b>5 Lakhs or above</b> research grant from industries in a calendar year.</li> <li>▪ Faculty who has received this award earlier can apply <b>after 3 Years</b> for this award.</li> </ul> <p>The award proposal will be sent through the institute's principal or director</p>								
4]	<p>Incentive</p> <ul style="list-style-type: none"> <li>• <b>5 % of Research Grant amount</b> received will be given as an incentives from institute funds (in research grant, Principal investigator will get 70 % and 30 % to Co-investigator if it is shown in the proposal; in research grant Principal and Vice- Principal share will not be applicable ). This amount will be excluding JRF/SRF Stipend.</li> </ul>								
5]	<p><b><u>Research Excellence Award- Publication</u></b></p> <p>Award comprised of prize of <b>Rs. 1100</b>, Certificate and Memento. Every year, this Award will be given to <b>two faculty members</b> per college having <b>highest IF in a academic year</b></p> <p>Faculty members shall meet the following requirements;</p> <ul style="list-style-type: none"> <li>▪ Having publications of total impact factor more than 3 in academic year</li> <li>▪ Main author or guide will be eligible for nomination.</li> <li>▪ Faculty who have received this award can apply after <b><u>3 Years for this award.</u></b></li> </ul> <p>The award proposal will be sent through the institute's principal or director.</p>								
6]	<p>Shirpur Education Society, Shirpur, will provide funding for patenting their innovations. This grant will be given only for investigator. 7]	<p>A grant of <b>₹ 50,000/-</b> will be given to a faculty member, a student, or both for a start-up initiative. The scheme is open to <b>both faculty and students</b>. (After 2 years' service in teaching and for students TY, Final Year and PG Students)</p> <ul style="list-style-type: none"> <li>▪ Every year, two projects will be approved per college.</li> <li>▪ The project funding will be approved based on the <b>recommendations of the RAC.</b></li> </ul>								



8]	<p>The faculty is eligible for a grant of up to ₹ 5,000 to attend the National Conference/Seminar. This will include either travel expenses <b>OR</b> conference registration fees <b>OR</b> both.</p> <p>For attending an <b>International conference outside of India</b>, a grant up to ₹25,000/- would be sanctioned against air fare/registration costs, whichever is less (<i>if financial assistance is not available from any government funding agencies</i>).</p>

10]	<p>Shirpur Education Society will provide a grant of ₹ 50,000/Year to organize <b>seminars or conferences</b> on the subject.</p> <ul style="list-style-type: none"> <li>Two departments of the college will get the same grant amount.</li> <li>This financial assistance will not be provided for two years in a row for the same departments.</li> </ul>										
11]	<p>Faculty who publishes their research in a journal with a high Impact Factor (IF) (Thomson Reuter) are eligible for a ₹ 5000/- <b>Prize</b> for research articles with an impact factor greater <b>than 5</b>. If a research publication's impact factor exceeds 5, faculty will be paid a multiple of ₹1000/-for each additional <b>1 IF</b>. This award will go to faculty (the paper's author/co-author). If, for example, two or more than two research papers (IF more than 5) are published by faculty in a calendar year then maximum of ₹ 10,000/- <b>prize</b> will be given to the faculty. Same faculty will not receive the prize for the two consecutive year in a row.</p>										
12]	<p>If the faculty has received award/Prize in <b>sports</b> at <b>National/ State level</b>; then, such faculty is entitled to get cash prize of ₹5,000 as motivational/promotional.</p>

- 13] SES will offer its employees a loyalty Incentive. Faculty who has completed at least **10 years** of service in SES/RCPET are eligible to apply for the Incentive Scheme. This scheme is applicable to non- grant faculty, supportive staff, and peon (Applicable to those who are on regular scale)

The detail of the scheme is as given below.

The above amount shall not be considered in basic and should be mentioned in other column as an incentive.**w.e.f from 1<sup>st</sup> July 2022.**

- 14] Faculty who publishes a book with National or International publishing houses (*Elsevier, Springer, Wiley, Taylor & Francis* etc), are eligible for a monetary benefit of **₹ 3000** (national) or **₹ 7000** (International). Hard copy of the book shall be submitted by author.
- ✓ If there are multiple authors/ co-authors from the same institute, then only one of them will be eligible to receive this grant or it can be shared among the authors/co-authors.
  - ✓ This cash benefit will not be applicable to author who have published book chapter.

**Note: 1]** Consideration of all above schemes will be subject to final decision of the Shirpur Education Society Expert committee.

- 2] Either - President Research Motivational Scheme -1 or Start Up Scheme-7 will be considered for final sanction.
